**ADOPTION OF GRANT COUNTY TITLE VI PROGRAM AND LIMITED
ENGLISH PROFICIENCY (LEP) PLAN**

WHEREAS, the Federal Government, through the Federal Transit Authority (FTA), provides financial assistance to develop new transit systems and improve, maintain, and operate existing systems. FTA oversees thousands of grants to hundreds of State and local transit providers. These grant recipients are responsible for managing their programs in accordance with Federal requirements; and

WHEREAS, Title VI of the Civil Rights Act of 1964 prohibits discrimination on the basis of race, color, or national origin in programs and activities receiving federal financial assistance. Specifically, Title VI provides that "no person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance." 42 U.S.C. § 2000d and 49 CFR part 21; and

WHEREAS, all recipients of Federal FTA funding are required to adopt a Title VI Program and a Limited English Proficiency Plan to carry out the mission of Title VI in relation to limited English proficiency. See Federal Transit Authority Circular 4702.1B; and

WHEREAS, Grant County is a recipient of Federal FTA funding; and

WHEREAS, in compliance with the FTA requirements, Grant County intends to provide a framework for the provision of timely and reasonable language assistance to LEP persons who come in contact with Grant County services by adopting a Title VI Program and a Limited English Proficiency Plan.

NOW THEREFORE, BE IT HEREBY RESOLVED, that the Grant County Board of Commissioners hereby adopts the Grant County Title VI Program and the Grant County Limited English Proficiency (LEP) Plan attached hereto.





GRANT COUNTY TITLE VI PROGRAM

I. Plan Statement

Title VI of the Civil Rights Act of 1964 prohibits discrimination on the basis of race, color, or national origin in programs and activities receiving federal financial assistance. Specifically, Title VI provides that “no person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance.” 42 U.S.C. § 2000d.

Grant County is committed to ensuring that no person is excluded from participation in, or denied the benefits of its county services on the basis of race, color, or national origin, as protected by Title VI in Federal Transit Administration Circular 4702.1.A and 4702.1B (Nov. 5, 2012).

This program was developed to guide Grant County in its administration and management of a Title VI policy.

II. Title VI Certifications and Assurances

The Certifications and Assurances have been submitted on Team Web.

III. Construction Statement

The County undertook the construction of a new detention facility, beginning August 9, 2010, which has been completed since its last Title VI Submission. The County has also undertaken a remodel of its business and conference center, and has begun construction on a fair barn building. The County has reviewed Chapter IV, Section 8, of FTA’s Title VI Circular.

V. Title VI Notification

The Grant County Notice of Title VI Rights is attached to this Program as Appendix B. The Notice of Title VI Rights form, along with the Title VI Program will be adopted by Resolution by the Grant County Board of Commissioners at a meeting open to the public and aired on the local public television station. The Resolution, which will include the entire Title VI Program will be available for public inspection in the Manager’s Office and will also be recorded in the Grant County Clerk’s Office. The Title VI Program will be disseminated to all current Grant County employees and will be given to all new hires during orientation, who will sign the acknowledgment form that is attached to this Program as Appendix C.

VI. Board Demographics

A. Grant County Board of Commissioners—Elected

Grant County, New Mexico is governed by the Grant County Board of Commissioners (GCBC). The Board has three elected members. Each member represents one of three districts within Grant County. A map depicting the three Districts is attached to this Program as Appendix D. District 1 is represented Commissioner Gabriel Ramos. District 2 is represented by Commissioner Brett Kasten. District 3 is represented by Commissioner Ron Hall. All three Commissioners are male. Two of the Commissioners are Caucasian and one of the Commissioners is Hispanic. The Board of Commissioners is the governing body of the Grant County, and as such, creates policy, approves most contracts, adopts resolutions and ordinances, and hires a County Manager to oversee the daily operation of the County and to oversee all personnel matters.

B. Area Transportation Authority Board—Not Appointed by Recipient

In 2006, the Southwest Regional Transit District (SWRTD) was formed by several local governing bodies in the Southwest Region of New Mexico. The members of SWRTD include the following Southwest New Mexico Governmental Entities: Grant County, the Town of Silver City, the City of Lordsburg, Luna County, the City of Deming, and Hidalgo County. SWRTD was formed to provide local bus services in the Southwest Region of New Mexico. This bus service is commonly known as “Corre Caminos.” SWRTD was governed by a Board of Directors, referred to as the Area Transportation Authority (“Authority Board”). Prior to 2006,

the local bus services were coordinated under a Joint Powers Agreement, entered into by the local government entities.

In approximately June of 2013, the Authority Board voted to transfer its authority to run the bus services to Grant County. The Authority Board now functions as an advisory board to the GCBC. The Authority Board is comprised of 6 members. The members of the authority board are not appointed by the recipient, but rather, are selected by each entity that is a member of SWRTD. Consequently, Grant County does not make efforts to encourage participation of minorities on the Authority Board. The table below indicates demographics of Authority Board.

VII. Public Participation Plan

As a local government, Grant County is subject to the New Mexico Open Meetings Act, NMSA (1978) § 10-15-1 et seq. Under this Act, the County Commissioners must meet in a meeting that is open to the public. The County Commissioners generally hold two regular open meetings on the second and fourth Thursday of each month. The meeting and its agenda must be properly noticed to the public in advance of the meeting. At this meeting, the public is invited to make public comment on any County business. In addition, the public is also permitted to engage in discussion on any agenda item that is up for approval or disapproval by the Board of Commissioners. This is the method by which the County ensures access to County business for the general public, including low-income and minority populations.

For all advertisements of GCBC public meetings, the public is notified of the following: “If you are an individual with a disability in need of a reader, amplifier, qualified sign language interpreter or any other form of auxiliary aide or service to attend or participate in the meeting or hearing, please contact the Grant County Manager at 1400 Highway 180 East, Silver City, New Mexico at least one (1) week prior to the meeting or as soon as possible.”

The GCBC meetings are advertised in the local newspaper. In addition, notice of the meetings is posted on the front door of the County Administration Building and on the Grant County Website. The agenda of the GCBC meetings is also available to the public in advance of the meetings. The agenda is published in the local newspaper and posted on the Grant County Website.

The Area Transportation Authority Board holds a meeting once a month to address the operations and services of Corre Caminos. These meetings are open to the public. These meetings are held in the Grant County Administration Building, which is conveniently located in Silver City, New Mexico. Notice of these meetings is published in the local newspapers in Deming, Lordsburg, and Silver City. Any changes in the scheduled time for these meetings is

posted at the Silver City Depot and the Deming Depot. Additionally, notice of any changes in the scheduled time for these meetings are forwarded to the Town of Silver City and the City of Deming for posting at those respective administration buildings. At these meetings, the public has an opportunity to make comment and to raise any concerns regarding the bus services. This is the method by which the County ensures access to County business, including the bus services, for the general public, including low-income and minority populations.

Almost 50% of Grant County's population is of Hispanic origin. Consequently, advertising through widely viewed media such as the local newspaper (which is also on-line) and Grant County's website should reach a significant number of the minority population of Grant County.

In addition, since Corre Caminos has come under Grant County control, notice of the Authority Board's public meetings will also be forwarded to the Income Support Division of the New Mexico Human Services Department in order to reach low-income populations. Further, notice of the meetings will also be forwarded to Literacy Link—Leamos, which is a local non-profit that teaches English as a Second Language courses and holds English Conversational classes.

Both GCBC and the Authority Board meetings are held at the Grant County Administration Building, which is located at 1400 Highway 180 East, Silver City, New Mexico. Silver City is the "county seat," and is conveniently located in the center of Grant County. There is a bus route from all member entities to the Grant County Administration Building.

These public meetings have been held prior to Grant County's initial submission of its Title VI Program, and have continued thereafter.

VIII. Active Investigations

As of May 23, 2013, and since Grant County's initial submission, there are no active transportation-related Title VI investigations, complaints, or lawsuits filed with the recipient.

APPENDIX A

GRANT COUNTY

TITLE VI COMPLAINT PROCESS

The County of Grant, New Mexico provides equal access to its programs and services to all citizens. This document serves to make citizens aware of their rights to such access, and serves to educate citizens so that they may understand the civil rights laws that protect their receipt and benefit of such services as defined by Title VI of the Civil Rights Act of 1964.

WHAT IS TITLE VI?

Title VI is a section of the Civil Rights Act of 1964 requiring that "No person in the United States shall on the grounds of race, color or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance." Note that Title VI does not address gender or age discrimination. It only covers race, color and national origin. Other Civil Rights laws prohibit gender and age discrimination.

COMPLAINT AND INVESTIGATION PROCEDURES:

These procedures cover all complaints filed under Title VI of the Civil Rights Act of 1964 for alleged discrimination in any program or activity administered by the County of Grant, New Mexico.

These procedures do not deny the right of the complainant to file formal complaints with other State or Federal agencies or to seek private counsel for complaints alleging discrimination. Every effort will be made to obtain early resolution of complaints at the lowest level possible. The option of informal mediation meeting(s) between the affected parties and Grant County may be utilized for resolution. Any individual, group of individuals or entity that believes they have been subjected to discrimination based on race, color, or national origin, prohibited under Title VI and related statutes may file a complaint.

1. A formal complaint must be filed within one-hundred and eighty (180) days of the alleged occurrence. Complaints shall be in writing and signed by the individual or his/her representative, and will include the complainant's name, address and telephone number; name of alleged discriminating official, basis of complaint (race, color, national origin), and the date of alleged act(s). A statement detailing the facts and circumstances of the alleged discrimination must accompany all complaints. A Grant County Title VI Complaint Form can be found at the end of this document. Grant County encourages individuals to submit Title VI complaints in writing using this form and mailing it to:

2. In the case where a Complainant is unable to or incapable of providing a written statement, a verbal complaint of discrimination may be made to the Grant County Title

VI Coordinator or his/her designee. Under these circumstances, the Complainant will be interviewed, and the Title VI Coordinator will assist the Complainant in completing a written statement.

3. When a complaint is received, the Title VI Coordinator or his/her designee will mail a written acknowledgment to the Complainant within ten (10) business days.
4. If a complaint is deemed incomplete, the Complainant will be notified such by mail and the Complainant shall have thirty (30) calendar days from receipt of the notice of incompleteness to resubmit the complaint with all required information. Failure to do so may be considered good cause for a determination of no investigative merit.
5. Within fifteen (15) business days from receipt of a complete complaint, Grant County will determine its jurisdiction in addressing the matter and whether the complaint has sufficient merit to warrant investigation. The Title VI Coordinator or his/her designee will mail this decision to the Complainant within fifteen (15) days from receipt of the complete complaint.
 - a. If the decision is not to investigate the complaint, the notification shall specifically state the reason for the decision.
 - b. If the complaint is to be investigated, the notification shall inform the Complainant that his/her full cooperation will be required in gathering additional information and assisting the investigator.
6. When Grant County does not have sufficient jurisdiction, the Title VI Coordinator or his/her authorized designee will refer the complaint to the appropriate State or Federal agency holding such jurisdiction.
7. If the complaint has investigative merit, a complete investigation will be conducted, and an investigative report will be submitted to the Grant County Manager within sixty (60) calendar days from receipt of the complete complaint. The report will include a description of the incident, summaries of all persons interviewed, and a finding with recommendations and proposed resolution where appropriate.
8. The Grant County Manager or his/her designee will review the investigative report.
9. The Grant County Manager will make a determination on the disposition of the complaint. Within ninety (90) calendar days from receipt of the complete complaint, notice will be mailed to the Complainant of the final decision reached and of any necessary remedial action that will be taken. The notice will state the Complainant's right to file a complaint with the Federal Transit Administration, as described below.
10. If the Complainant is dissatisfied with the Grant County's resolution of the complaint, he/she has the right to file a complaint with:

11. A copy of the complaint, investigation report, and the notice sent to Complainant will be forwarded to the Federal Transit Authority (FTA) within one-hundred and twenty (120) days of the receipt of the complaint.
12. A summary of the complaint and its resolution will be included as part of the Title VI updates to the FTA.

RECORD KEEPING

The Title VI Coordinator will ensure that all records relating to Grant County's Title VI Complaint Process are maintained with department records and will be available for compliance review audits.



APPENDIX E

CORRE CAMINOS TRANSIT TITLE VI SYSTEM-WIDE SERVICE STANDARDS AND POLICIES

I. Background

The Federal Transit Administration (FTA) requires that all fixed route providers of public transportation develop standards for the following elements of service, in compliance with the provisions of Title VI.

A. Service Standards Requirements:

- Vehicle load: ratio of passengers to the number of seats on the bus;
- Vehicle headways: amount of time between two buses traveling in the same direction on the same route;
- On-time performance: measure of runs completed on schedule; and
- Service availability: measure of the distribution of routes within the service area.

B. Service Policy Requirements:

- Vehicle assignment; and
- Transit amenities.

II. Service Standards

A. Vehicle Load: Vehicle loads shall not exceed 1.5 on fixed in city routes and shall not exceed 1.0 outside of fixed city routes. (Note: The vehicle load standard is expressed as a ratio of passengers to the number of seats available on a particular vehicle.)

B. Vehicle Headway: Corre Caminos Transit does not have vehicle headways, nor does it have peak and off-peak periods. Corre Caminos Transit has only one bus per route, so there are never two vehicles traveling the same route. The following table depicts the approximate frequency of stops for the Corre Caminos Transit fixed routes.

C. On-time Performance: A Corre Caminos Transit bus is considered on time for a fixed route if it departs no earlier than the established departure time and no more than ten (10) minutes late. Corre Caminos Transit's on-time performance objective is 90 percent or greater. Corre Caminos Transit currently monitors on-time performance through reports from drivers and passenger comments. Problem routes may be surveyed to determine more precise performance characteristics and potential remedies. As Corre Caminos Transit operates a deviated fixed route system, some routes may be subject to wide variations in on-time performance when a large number of deviations are scheduled.

D. Service Availability: Corre Caminos Transit endeavors to distribute transit service based on a balance of need and resources. For instance, there are more frequent bus stops in the more densely populated municipalities in the service area. In choosing a particular location for a bus stop, Corre Caminos Transit should attempt to locate the bus stops within walking distance of commonly used destinations such as the hospital, a grocery store, an apartment complex, or a retirement community. The location of routes and bus stops is affected by the service area covered by Corre Caminos Transit, which covers several municipalities spread across three counties. There is a significant amount of rural miles to travel in between the municipalities. Choice of locations/availability is also affected by the funding from the local members of the Southwest Regional Transit District, which limits the scope of Corre Caminos Transit's services.

III. Service Policies

A. Vehicle Assignment:

Vehicles should be assigned to routes based on ridership and the conditions of the route, and vehicle availability and condition. For instance, larger units with more seating should be assigned to routes with higher ridership, and units with bike racks may be assigned to routes with frequent bike riders. Corre Caminos Transit should make every effort to ensure that all vehicles assigned to a route are fully functioning with heating and air conditioning. In the event that Corre Caminos Transit must use a vehicle that does not have properly functioning air condition in the summer, because there are no other vehicles available, that unit should be used for shorter routes with lower ridership. A vehicle that does not have properly functioning heat will not be used during the winter.

B. Distribution of Transit Amenities:

Transit amenities refer to items of comfort, convenience, and safety that are available to the general riding public. Corre Caminos Transit has limited financial resources, and therefore distributes few amenities. Installation of transit amenities (shelters, benches, signage) is based on route and stop characteristics, such as route ridership and individual stop boardings, safety, as well as input from member jurisdictions. Corre Caminos strives to distribute transit amenities in an equitable manner, taking into consideration need and resources.

As the budget permits, shelters should first be placed at bus stops that have longer waits and bus stops that have more frequent use. All of the shelters should have benches and seating should be maintained at all Depots.

For all fixed routes, bus stop signs and seating should be located at as many bus stops as the budget will allow, taking into consideration need and ridership when determining order of distribution.

Printed route information should be provided at all Depots, and will be distributed to local venues and businesses, such as the Visitors Center and hotels. Route information shall also be available on all buses and at the administration buildings of Grant County, Luna County, and Hidalgo County.







APPENDIX G

GRANT COUNTY LIMITED ENGLISH PROFICIENCY (LEP) PLAN

I. LEGAL BASIS AND PURPOSE

This document serves as the plan for Grant County, New Mexico to provide services to LEP individuals in compliance with Title VI of the Civil Rights Act of 1964; 45 C.F.R. § 80 et seq; and 28 C.F.R. § 42 et seq. The purpose of this plan is to provide a framework for the provision of timely and reasonable language assistance to LEP persons who come in contact with Grant County services.

II. POLICY

The county's policy is to take reasonable steps to provide timely, meaningful access to LEP persons to the services and benefits that the county provides in all county departments and/or offices. All county personnel shall assist LEP individuals whom they encounter or whenever an LEP individual requests language assistance services.

III. FOUR-FACTOR ANALYSIS NEEDS ASSESSMENT

Grant County is responsible for conducting a needs assessment and developing a local LEP to meet the county-related needs. The county should review its needs assessment triennially and determine whether changes to its LEP Plan are required. This may include consulting new demographic information, observing trends in the usage of county services, ensuring that its customers have access to Spanish speaking individuals, reviewing translated materials, training new employees, and finding out what new services are being offered. The LEP Plan should consider the county's demographics and language needs, the frequency with which LEP persons use county services, the importance of the services offered, and possibly a cost-benefit analysis.

A. Demographics—The Proportion of LEP Persons Served or Encountered in the Eligible Service Population

Grant County provides general services to the residents of Grant County. In addition, the bus service, Corre Caminos Transit, that is run by Grant County also provides services to residents of Hidalgo County and Luna County. The language data from the 2000 US census and the 2006-2010 US census for Grant County, Hidalgo County, and Luna County are attached to this plan, as Appendix 2-A, showing foreign language speakers and the number of speakers who speak English less than "very well." These reports can be found at www.census.gov. The following data was gathered and analyzed from these reports:

Grant County Language Demographics for 2000

- The population of five years and older of Grant County was 28,911 of which 63.3% spoke only English and 36.7% spoke a language other than English.
- Of the population, 35.6% spoke Spanish or Spanish Creole.
- Of the Spanish speakers, 74.3% spoke English very well, 20.1% spoke English well, and 4.9% spoke English not well, and 0.7% spoke English not at all.

- Other languages spoken included 0.3% German, 0.2% Navajo, 0.2% French, 0.1% Laotian, and 0.1% Hungarian.
- Of the Indo-European languages, 85.2 % spoke English very well, 5.6% spoke English well, 9.3% spoke English not well, and 0.0% spoke English not at all.
- Of the Asian and Pacific Island languages, 85.7% spoke English very well, 14.3% spoke English well, 0.0% spoke English not well, and 0.0% spoke English not at all.
- Of all other languages, 65.8% spoke English very well, 32.9% spoke English well, 1.4% spoke English not well, and 0.0% spoke English not at all.
- Languages spoken, other than English and Spanish, make up less than 1% of the Grant County population.

Grant County Language Demographics for 2006-2010

- The population of five years and older is 27,922 of which 66.51% speak only English and 33.49% speak a language other than English.
- Of the population, 31.97% speak Spanish (or Spanish Creole) of which 5.97% speak English less than very well.
- Of the population, .057% speak French; .057% speak French Creole; .061% speak Italian; .265% speak Portuguese (or Portuguese Creole); .387% speak German; .039% speak other West Germanic languages; .011% speak Scandinavian languages; .211% speak Chinese; .032% speak Korean; .057% speak Tagalog; .208% speak Navajo; .025% speak other Native North American languages; .021% speak Hungarian; and .089% speak Hebrew.
- Languages spoken, other than Spanish and English, make up less than one percent of the Grant County population.

Hidalgo County Language Demographics for 2000

- The population of five years and older was 5,473 of which 56.4% speak only English and 43.6% speak a language other than English.
- Of the population, 43.3% speak Spanish of which 64.2% speak English very well, 19.9% speak English well, 9.8 % speak English not well, and 6.2 % speak English not at all.
- Of the population, other languages spoken include .26% speak other Indo-European Languages, .037% speak Asian and Pacific Island Languages, and 0% speak other languages.
- Of the Indo-European Languages, 71.4% speak English very well, 0.0% speak English well, 28.6% speak English not well, and 0.0% speak English not at all.
- Of the Asian and Pacific Island Languages, 0.0% speak English very well, 0.0% speak English well, 100% speak English not well, and 0.0% speak English not at all.
- Of all other languages, 0.0% spoke English very well, 0.0% spoke English well, 0.0% spoke English not well, and 0.0% spoke English not at all.
- Non-English and non-Spanish languages spoken make up less than 1% of the population of Hidalgo County.

Hidalgo County Language Demographics for 2006-2010

- The population of five years and older is 4,533 of which 59.8% speak only English and 40.2% speak a language other than English.

- Of the population, 39.11% speak Spanish (or Spanish Creole) of which 20.87% speak English less than very well.
- Of the population, 0.15% speak Italian; .066% speak Portuguese (or Portuguese Creole); .44% speak German; .31% speak other Native North American languages; and .13% speak Hebrew.
- Languages spoken, other than Spanish and English, make up less than two percent of the Hidalgo County population.

Luna County Language Demographics for 2000

- The population of five years and older was 23,130 of which 50.5% speak only English and 49.5% speak a language other than English.
- Of the population, 48.7% speak Spanish of which 55.6% speak English very well, 19% speak English well, 13.5% speak English not well, and 11.9% speak English not at all.
- Of the population, other languages spoken include .58% speak other Indo-European Languages, .13% speak Asian and Pacific Island Languages, and .10% speak other languages.
- Of the Indo-European Languages, 80.5% speak English very well, 10.5% speak English well, 2.3% speak English not well, and 6.8% speak English not at all.
- Of the Asian and Pacific Island Languages, 89.7% speak English very well, 10.3% speak English well, 0.0% speak English not well, and 0.0% speak English not at all.
- Of all other languages, 29.2% spoke English very well, 45.8% spoke English well, 25% spoke English not well, and 0.0% spoke English not at all.
- Non-English and non-Spanish languages spoken make up less than 1% of the population of Hidalgo County.

Luna County Language Demographics for 2006-2010

- The population of five years and older is 23,292 of which 51.39% speak only English and 48.61% speak a language other than English.
- Of the population, 47.92% speak Spanish (or Spanish Creole) of which 34.55% speak English less than very well.
- Of the population, .082% speak French, .039% speak Italian; .077% speak German; .052% speak other Slavic Languages, .167% speak other Indo-European languages, .043% speak Chinese, .026% speak Korean, .060% speak Tagalog, .077% speak Navajo, and .069% speak Hungarian.
- Languages spoken, other than Spanish and English, make up less than one percent of the Luna County population.

Grant County's Prior Experience with LEP Individuals

All Departments of Grant County have encountered LEP individuals that speak Spanish, on a regular basis. Fortunately, Grant County employs numerous employees in virtually every department that speak Spanish that can assist in translating for Spanish speaking LEP individuals. Consequently, Grant County has been successful in providing services in all of its departments to LEP individuals. Grant County has also provided services to non-Spanish speaking LEP individuals on an infrequent basis, which is further addressed in the next section.

Actual language demographics for Corre Caminos ridership is not available. However, Grant County does see trends in the Corre Caminos ridership. For instance, the majority of our ridership is elderly and/or low income. There are some students, members of the work force, and disabled individuals that are riding Corre Caminos. There are a significant number of Spanish speakers riding Corre Caminos, and Grant County estimates that approximately 10 to 15% of the riders in Grant County are Spanish speakers, approximately half of the riders in Deming speak Spanish, and approximately 70 to 80% of the riders in Luna County are Spanish Speakers. Many of the Spanish speakers, however, also speak English. Some of the Spanish speakers speak English less than very well. The ridership statistics that are collected by Corre Caminos are attached to this Plan as Appendix 2-B.

Language Demographics Summary

Based on the demographic information gathered above, it appears that there is a large population of Spanish speaking individuals in Grant County, somewhere in between 31.97% to 35.6% of Grant County's population. Of those Spanish speakers, at least 5.6 and 5.97% of the population in Grant County are limited in English proficiency. These numbers increase in Hidalgo and Luna Counties, where the Spanish speaking population is approximately between 43.3 and 48.7%, with in between 34.55 and 44.4% of the Hidalgo County Spanish speakers speaking English less than very well and between 20.87 and 35.9% of the Luna County Spanish speakers speaking English less than very well. It also appears that a significant number of the Corre Caminos ridership is Spanish speaking and may need language assistance.

For the most part, the non-English, non-Spanish speaking population totals less than one percent of the each of the counties populations.

B. The Frequency that LEP Persons Come Into Contact with Grant County Programs

Grant County Departments and Programs

Grant County has several offices and departments that serve the public, including Sheriff's Office, the Treasurer's Office, the Assessor's Office, the Clerk's Office, the Grant County Detention Center, the Grant County Road Department, the Grant County Public Works Department, the Grant County Seniors Program, the Grant County DWI Program, the Grant County Airport, the Grant County Planning Department, and the Manager's Office.

In 2006, the Southwest Regional Transit District (SWRTD) was formed by several local governing bodies in the Southwest Region of New Mexico. The members of SWRTD include the following Southwest New Mexico Governmental Entities: Grant County, the Town of Silver City, the City of Lordsburg, Luna County, the City of Deming, and Hidalgo County. SWRTD was formed to provide local bus services in the Southwest Region of New Mexico. This bus service is commonly known as Corre Caminos Transit. SWRTD was governed by a Board of Directors, referred to as the Area Transportation Authority ("Authority Board"). Prior to 2006, the local bus services were coordinated under a Joint Powers Agreement, entered into by the local government entities. In approximately June of 2013, the Authority Board voted to transfer its authority to run the bus services to Grant County.

Grant County LEP Survey

A survey was taken by Grant County. Data from the survey is attached to this plan, as Appendix 2-C. The purpose of the survey was to determine if non-English speaking individuals are using Grant County services; and if so, what language(s) do they speak and what departments do they use frequently. The survey was also geared to determine if we have a significant number of employees who are fluent in Spanish.

The survey indicates that Grant County staff regularly encounters customers who speak English less than very well and require language assistance. The survey also indicates that nearly all of the surveyed employees' encounters were with LEP individuals who spoke Spanish. Other encounters with LEPs included the following languages: German; Chinese; Korean; Japanese; Mandarin; Russian; French; and an African Language. It appears that most all of the departments have frequent encounters with Spanish speaking LEP individuals, and that the Sheriff's Office and Corre Caminos Transit also encounter on an infrequent basis LEPs speaking languages other than Spanish.

Summary of LEP Needs Assessment

Based on the information/data collected, there is a clear need to facilitate language services for Spanish speaking LEP individuals in all Grant County Departments. As for non-Spanish speaking LEP individuals, it appears that their encounters with county services are infrequent. Accordingly, Grant County should be prepared for a non-Spanish LEP encounter, but will require less enhanced language services for non-Spanish LEP encounters, such as in the Sheriff's Office and Corre Caminos.

C. The Nature and Importance of Grant County Services

Most of the services provided by the county are of high importance to the public in that the services are unique to the county offices/departments and engaging in those services is often required by law. For instance, the Grant County Clerk's Office is the only place in Grant County that a citizen can file certain public records or vote, and the Grant County Treasurer's Office is the only place in Grant County that a citizen can pay his or her property taxes. The high importance of the county services is also due to many of the services being related to basic rights, such as voting or being incarcerated. The county also provides emergency services, such as that provided by the Sheriff's Office. The bus service, Corre Caminos Transit, is also of high importance in this area due to a large population of low-income and elderly individuals in the Southwest New Mexico region that rely on it. In addition, there are several remote communities in the Southwest region, and the citizens living in those communities may not have transportation for basic needs, such as food, without the bus service. It is essential that all citizens, including LEP individuals, are able to obtain the services provided by Grant County.

D. Language Assistance Resources and Costs

Currently, several of the county Departments/Offices already have LEP assistance in place. For instance, at the Sheriff's Office, the Miranda Warning and the Notice of Implied Consent are available in Spanish. And in the Clerk's Office, all voter registration and election materials are available in both English and Spanish. At the Senior Centers, signs, pamphlets, and surveys are

provided in English and Spanish. In the Planning Department, Fire Management Division, there are "Defensive Space" handouts that are translated in Spanish. Notices and some route schedules provided by Corre Caminos Transit are available in both English and Spanish, and postings on the buses are in English and Spanish. These are just some of the language assistance tools already in place at Grant County.

The county also has a substantial number of employees, in nearly every department, who speak Spanish fluently, which the county uses on a regular basis for assisting LEP individuals. Employee interpreters/translators are the most commonly used method of language assistance used by the county, and using employee interpreters/translators has been very successful. Consequently, any cost to the county for English-Spanish translation services, written or oral, will be minimal if any.

As for personnel resources, the Manager's Office Executive Assistant will coordinate any necessary language assistance that cannot be handled by a department. For instance, if one department is attempting to find someone to translate from another department, the Executive Assistant could coordinate this. And as described above, there are numerous potential Spanish translators employed by the county. The Human Resource Specialist will coordinate the Title VI complaint process. The county has sufficient personnel resources to coordinate any necessary language assistance.

Although infrequent, the county does have non-English, non-Spanish speakers using county services. For these encounters, the county will need to go outside of its organization for language assistance. The county intends to use telephonic interpreter services. The county estimates that the service will cost approximately \$4.00 per minute. Because the telephonic services will be used so infrequently, the county expects such a cost to be minimal. Based on the language demographics of Grant County, Hidalgo County, and Luna County, and the Grant County LEP surveys, the county will need occasional outside assistance for several non-Spanish languages, including but not limited to the following: German; Chinese; Korean; Japanese; Mandarin; French; Italian; Slavic Languages; Tagalog; Navajo; Hungarian; Portuguese; Hebrew; Scandinavian languages; and other Native North American languages.

Because the county already has so many language assistance resources in place, the minimal cost of those resources is already built in to the county's budget. Further, the county estimates that any additional costs incurred in obtaining non-Spanish/English interpreters outside of its organization will be minimal and, therefore, will not be an unreasonable cost to the county.

IV. LANGUAGE ASSISTANCE MEASURES

A. Identification of an LEP Individual:

- Examine records to see if requests for language assistance have been received in the past, either at meetings or over the phone, to determine whether language assistance might be needed at future events or meetings.

- Have a staff person in each department greet individuals who have come to the county for services. By informally engaging individuals in conversation it is possible to gauge each attendee's ability to speak and understand English.
- Have Census Bureau Language Identification Flashcards available at county Departments/Offices.

B. Assistance to LEP Individual

- The county will continue to provide the translated documents and signs in English/Spanish currently available and will further evaluate whether more translated documents and/or signs are necessary.
- The county will continue to use Spanish speaking employees to assist LEP individuals in obtaining county services.
- Corre Caminos will provide telephonic route information in both English and Spanish.
- The county will make Language Identification Flashcards available at all of its Departments/Offices, attached as Appendix 2-E to this Plan.
- A list of employees who are fluent in Spanish will be provided to all Departments/Offices, attached as Appendix 2-F to this Plan.
- The county will provide the Title VI Plan to all county Departments and provide directions for implementing the Plan to each Department.
- The county will review the Title VI Plan and the Title VI Complaint Procedure with all new employees.
- The county will train the Human Resources Specialist and the Manager's Office Executive Assistant for their respective roles in implementing the Title VI Program.
- The county will include "Spanish a plus" language in job advertisements.
- The county will utilize outside/telephonic interpreter services when language assistance is needed for a language other than Spanish.
- A list of New Mexico Interpreters will be provided to the Manager's Office Executive Assistant, who will coordinate assistance from outside interpreters when necessary.
- The county will choose a 24-hour telephonic interpreter service for non-Spanish language assistance, which may be used by the county's emergency services departments during non-business hours.

V. PUBLIC NOTIFICATION AND EVALUATION OF LEP PLAN

A. LEP Plan Approval and Notification

The Grant County LEP Plan has been approved by the Grant County Board of Commissioners, by Resolution. Any revisions to the plan will be submitted to the Grant County Board of Commissioners for approval. Copies of Grant County's LEP Plan will be provided upon request. In addition, Grant County will post this Plan, a Notice of Title VI Rights, and the Title VI Complaint Process on its website, <http://www.grantcountynm.com>. The Plan will also be recorded in the Grant County Clerk's Office.

B. Triennial Evaluation of the LEP Plan

The county will conduct a triennial needs assessment to determine whether changes to the LEP plan are required. Any revisions made to the Plan will be communicated to all county personnel, and an updated version of the plan will be posted on the county's website.

Estimates of urban and rural population, housing units, and characteristics reflect boundaries of urban areas defined based on Census 2000 data. Boundaries for urban areas have not been updated since Census 2000. As a result, data for urban and rural areas from the ACS do not necessarily reflect the results of ongoing urbanization.
